As per the Public Notice issued by the Member Secretary, NCTE, New Delhi on 17.06.2017, the Tamil Nadu Teachers Education University in the capacity of Affiliating Body brings to the notice of the General Public including Prospective students seeking admissions for academic session 2017-2018 only in the Colleges of Education provided in the list by NCTE.

It is further advised that the Colleges of Education, which are not mentioned in the List, in case they admit students for academic session 2017-2018, they do so at their own risk and the Tamil Nadu Teachers Education University shall not be held responsible for such admission of students.

NCTE has now re-opened its Mandatory Affidavit System (MAS) to afford a final opportunity to non-filers. The Colleges of Education who have already filed the affidavit are also required to re-validate their submission and provide additional information. PUBLIC NOTICE

The National Council for Teacher Education (NCTE) is a statutory body established by the Government of India under MHRD with a view to achieve planned and co-ordinated development of the Teacher Education System, along with their regulation and proper maintenance of norms and standards throughout the country and matters connected therewith.

The NCTE Regulation, 2014, u/s 8(12) mandates as under *“The institution shall make the information or documents available to the Council or its authorized representative as and when required by them and failure to produce or show any of the required documents, shall be treated as a breach of the condition of recognition”*. In light of this Section, an affidavit was required to be filled online by the Teacher Education Institutions (TEIs).

The whole fulcrum of the affidavit is to ensure transparency and proper monitoring of recognised institutions continuously on the basis of information provided by this medium and to prepare a database of TEIs throughout the Country.

It is hereby brought to the attention of all prospective student teacher, TEIs, State Governments and Affiliating Bodies that Institutions mentioned in the List -I as provided in the annexure to this Public Notice may be treated for now as being prima facie the Sole list of Institutions that are compliant with our notice dated 17.03.2017, which is subject to the outcome of verification of details submitted. Furthermore, affiliating bodies may advise TEIs in their jurisdiction, which do not find mention in List-I, that in case they admit students for academic session 2017-18 they do so at their own risk. A list with respect to the TEIs may be prepared by the Affiliating Body and State Governments which do not fall in the List-I and are within their jurisdiction and said list may be urgently communicated to NCTE vide e-mail at inspection@ncte-india.org.

This is further to bring to the notice of the General Public including prospective students, to seek admissions, only in the list of Institutions, provided under List- I, which is annexed herewith.

NCTE had launched an online Mandatory Affidavit system (MAS) on 05.10.2016 and the final date for submission was 15.11.2016, which was extended to 12.12.2016. Thereafter, NCTE, by Public Notice dated 17.03.2017, gave an opportunity to TEIs for submitting reply to Show Cause Notice, failing which, the NCTE shall be constrained to initiate processes leading to consequential action of withdrawal of recognition under Section 17 (1) NCTE Act, 1993. The last date for submission of reply to Show Cause Notice was 17.04.2017. The said deadline was further extended to 08.05.2017.

NCTE has now re-opened its Mandatory Affidavit System (MAS) to afford a final opportunity to non-filers. TEIs who have already filed the affidavit are also required to re-validate their submission and provide additional information. The last date for updating and fresh submission is 15.07.2017.
