I wish to draw your kind attention to the items under subject and to inform you as follows:-

New Syllabus/Regulations

The prescription of uniform Syllabus and Regulations for Tamil Nadu Teachers Education University for the academic year 2008-2009 is under consideration. A copy of Syllabus and Regulations will be sent to your Colleges during the last week of August 2008.

Fresh Affiliation/Additional Intakes

I am also by direction of the Vice-Chancellor to inform that the last date of receipt of application for the affiliation of fresh course in the existing Colleges/increase in intake in existing course for the academic year 2009-2010 will be 31st October 2008. You should apply in the prescribed form which is available for sale at the Registrar's Office on payment of Rs.100/- in the form of Demand Draft drawn in favour of "The Registrar, Tamil Nadu Teachers Education University, Chennai – 600 005".

The filled in application form supported by necessary enclosures along with the processing fee prescribed by the University for each course in the form of Demand Draft in favour of the Registrar, Tamil Nadu Teacher Education University, Chennai-5 should reach the University on or before 31-10-2008 for the academic year 2009-2010.

Continuation of Provisional Affiliation

Provisional affiliation is granted for the prospective academic year only. Thereafter the college shall apply for continuation of Provisional affiliation well in advance before the commencement of third academic year. Application for continuation of Provisional affiliation shall be complete in all respects and sent to the Registrar with the prescribed processing fees on or before 31st March of the respective year. No college will be permitted to admit students without obtaining proper approval for continuation of Provisional affiliation for third year from the University. After completion of 5 years of existence, college shall apply for permanent affiliation in the prescribed format.

Logo for the University

I am further to inform you that, it is proposed to design a Logo in tune with the objects of the University established for the noble cause of Education.

Since designing the Logo is an important aspect of the University, it is decided to invite innovative designs focusing ideas of the Tamil Nadu Teachers Education University giving wide opportunity to the Students and Teachers of affiliated Colleges of Tamil Nadu Teachers Education University.
