

As you are aware, the National Foundation for Communal Harmony (NFCH) is an autonomous organization with the Ministry of Home Affairs. Its principal objective is the promotion of communal harmony, fraternity and national integration. Along with this, the Foundation also looks after the physical and psychological rehabilitation of the child victims of communal, caste, ethnic and terrorist violence. As on date, nearly 11000 such children have been benefited from the Foundation's scheme of assisting the child victims.

2. The Foundation has instituted two National Communal Harmony Awards – one each for an individual and an organization, to be given annually for outstanding contribution to promotion of communal harmony and national integration. The Award consists of a citation and cash prize of Rs.2.00 lakh in individual category and a citation and cash prize of Rs.5.00 lakh in the organization category. A Jury headed by the Vice-President of India makes selection for conferment of awards.

3. The State Governments and Union Territory administrations are familiar with individuals and organizations engaged in the promotion of national integration and communal harmony in their respective States/Union Territories. However, experience shows that the matter of nominations / recommendations in respect of these prestigious awards requires much greater personal attention at various levels than is evidently happening at present, both in quantitative and qualitative terms. Keeping this in view, I request you to kindly look into this personally, and have necessary steps taken so that well considered nominations of eligible individuals / organizations for the said awards for the year 2011 are forwarded to the Secretary, National Foundation for Communal Harmony, by the 30<sup>th</sup> June 2011.

4. A brochure giving details of the National Communal Harmony Awards scheme is also enclosed.

## The National Communal Harmony Awards

The National Foundation for Communal Harmony is an autonomous body registered under the Societies Registration Act, 1860. It was set up by the Government of India in 1992 for promotion of communal harmony and national integration. The Foundation has instituted two "National Communal Harmony Awards" - one each for an individual and an organisation. The awards are given every year for outstanding contribution to promotion of communal harmony and/or national integration over a period of time. The awards carry a citation and cash amount as indicated below.

- (i) Individual : Rs. 2.00 lakh
- (ii) Organisation : Rs. 5.00 lakh

The awards are being regulated as under :-

### 1. Objectives

- (a) The awards have been instituted to promote communal harmony by recognising activities relating to :-
- (i) discouraging communal ill-will and regional animosities and weaning the misguided elements of society away from the path of violence;
  - (ii) active and energetic propagation of the principles, especially of tolerance and harmony;
  - (iii) mobilising constructive forces of society in the cause of national unity and solidarity and giving them leadership, encouragement and articulation;
  - (iv) devising suitable community activities and programmes for fostering fellow feeling emphasising the secular character of the country;
  - (v) propagating and working for national integration and harmony between different communities, irrespective of religious, linguistic or ethnic differences; and
  - (vi) asserting the common values and cultural ties which bind or act as unifying factor among the people living in this country.

## **2. Eligibility**

The awards are given to an individual and an organisation on the basis of their activities and performance over a sufficiently long period of time rather than on the basis of a single or sporadic act in any situation.

- (a) An individual is eligible for consideration of the award if he/she:
  - (i) has been working in the area of national integration and communal harmony for a minimum period of ten years;
  - (ii) does not hold any elective office in Parliament, State Legislature or local body constituted under an Act of Parliament or the State Legislature;
  - (iii) is not a member of a political party recognised by the Election Commission of India; and
  - (iv) is above 35 years of age and is alive on the date of nomination.
- (b) In the case of an organisation, it is essential that the organisation:
  - (i) is registered under an appropriate Act of Parliament or State legislature;
  - (ii) has been working at the all India level, or at least state level, (in case activities of the organisation are at the state level, these should be spatially well dispersed and extended to cover a substantial area of the state); and
  - (iii) should have been functioning for a minimum of five years in the field of promotion of national integration and communal harmony.
- (c) No educational institution or a body created under an Act of Parliament or State Legislature is eligible for the awards.

### **3. Method of selection**

- (a) The nominations for the awards shall be sent by (i) state governments/union territory administrations, (ii) municipal corporation/municipal board/zila panchayats by whatever name they are called in a state, (iii) Speakers of Lok Sabha/Vidhan Sabhas, (iv) Members of Parliament and State Legislatures, (v) members of the national Integration Council/Governing council or Executive Council of the National Foundation for Communal Harmony (vi) Vice-Chancellors of universities (vii) Recipients of the National Communal Harmony Awards and (viii) organisations of repute dedicated to promotion of communal harmony and national integration. Nominations can not be made by an organisation for itself or for any of its members.
- (b) Nominations shall be accompanied by a script typed on electronic gadgets or typewriter in English or Hindi indicating the outstanding contribution made year-wise, by the individual/organisation duly signed by the person making the nomination indicating the reasons why he/she considers him/her or the organisation as deserving the award. The nominating authority should clearly indicate its name and designation and category in which it falls.
- (c) Nominations for organisations shall also be accompanied by a copy of the registration certificate, rules and bye-laws of the organisation, names of office bearers and their addresses alongwith relationship between different office bearers, and audited statement of accounts during the last three years and a resume of the outstanding work done by the organisation.
- (d) The last date for receipt of the nominations is the 30th June of a year.
- (e) Convassing in any form in respect of a nomination shall render it disqualifed.
- (f) Nominations shall be considered by a jury and its decision in respect of the award shall be final.

### **4. Announcement of awards**

The awards shall be announced every year on the 26th January.

### **5. Presentation**

- (i) Presentation of the awards shall be made at a ceremony to be organised by the National Foundation for Communal harmony (NFCH).
- (ii) The recipient of the award shall be reimbursed to and fro expenditure for attending the investiture ceremony for the presentation of award as per rules of NFCH.

### **6. General**

- (i) All correspondence in the matter should be made either in Hindi or English. In case documents in regional languages are enclosed, their translation in Hindi or English should accompany the proposal.
- (ii) Any person/organisation nominated for the award shall be deemed to have accepted these rules.
