Sub: TNTEU – Academic year 2017-18 – II year B.Ed Students -16-Week Internship Programme in Schools – Orders of the CEO & Certificates issued by the School concerned for 16-Week Internship programme – Called for – Reg.

I am, by direction to inform that the 16-Week School Internship programme is the essential component of the 2-year B.Ed degree programme, which is intended to develop good teaching skills in practicing teachers. Hence, in the reference cited, the University has issued a set of instructions to all the Colleges of Education affiliated to this University in respect of conducting 16-Week School Internship Programme systematically for II year B.Ed students from **01.08.2017 to 15.12.2017**.

Accordingly, based on the proceedings of the Chief Educational Officers, the 16-Week School Internship programme has been completed by the students at the Schools specified. Further, the Practical Examination for II year B.Ed students have been completed on 27.02.2018 and the practical marks awarded by the Examiners to each student have been received by this University for further process. In order to complete the process of results of practical examination along with the various complaints on Internship programme held in Schools, the following documents in original are absolutely required for verification by the University.

1. A photocopy of the order of the Chief Educational Officer allotting the II year B.Ed students for 16-Week School Internship programme.
2. Original certificates on completion of 16-Week School Internship programme issued by the Headmaster of the School concerned to the II year B.Ed students.

Hence, the Principals/Managements of all the Self-Financing Colleges of Education are hereby instructed to submit the above two documents to the University immediately by keeping the photocopies of the same with them for future reference.

If any of the College of Education has already handed over the School Internship certificates in original through the Examiner, they shall also send the photocopies of School Internship certificates along with the copy of the order of the Chief Educational Officer.

It is further informed that the results of the practical examinations will be published only after the verification of the above two documents and in the case of **failure to submit the above two documents to the University, the results of practical examination will be withheld.**

In this regard, the Principals/Managements of the Colleges of Education are further informed that **the hall tickets for II year B.Ed students to appear for Written Examination will be released only to the Colleges who have submitted the above two documents to the University.** Hence, the Principals/Managements are requested to take top priority over this matter.
