**Sub:** Filling up of Geographical Information System (GIS) DATA by all the Teacher Education Institutions on NCTE website – Reg.

**Ref:** Letter No.SRO/NCTE/RD/2015/74603, dated 26.09.2015 addressed to the Principal Secretary, Education Department, Secretariat received through Email dated 26.09.2015.

In the letter cited at reference, the Regional Director, SRC, NCTE, Bangalore addressed to the Principal Secretary, Education Department, Secretariat has informed as follows:

“As required by National Council for Teacher Education (NCTE) as well as Govt. of India all the teacher education institutions are required to submit GIS DATA of their respective institutions at NCTE website [www.ncte-india.org](http://www.ncte-india.org).

In this connection, we seek co-operation in completing the mapping of all the Teacher Education Institutions. A letter in this regard has been sent to all the Teacher Education Institutions under the Southern Regional Committee, NCTE on 24.06.2015. In spite of this letter and the information hosted on SRC website, a many number of colleges have not submitted the GIS DATA.

Further, the GIS DATA of those colleges submitted is verified with the DATA submitted to NCTE's office and it is found that the data submitted by some colleges in GIS application is not correct. An e-mail to this effect has also sent on the e-mail ID submitted by the colleges in their GIS application. All these colleges will have to resubmit the DATA as per the remarks sent on e-mail.

It is further informed that **all the colleges that have not submitted GIS DATA or have not resubmitted after rejection message and on e-mail will be removed from the Teacher Education Institution database on NCTE and subsequently Recognition granted will be withdrawn without further notice.**

A letter and Public Notice to this effect is already sent to all the colleges. As such we request to kindly send this message from our office to all the Teacher Education Institution in our State either directly or through any other means as felt appropriate.”

Accordingly, the above instructions of the NCTE are hereby communicated for information and necessary action, with instruction to resubmit the DATA as per the remarks sent on e-mail by NCTE, as early as possible to avoid any action by the NCTE to withdraw the recognition granted to the affiliated colleges.
