

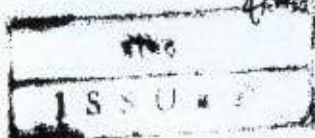
It has come to the notice of University Grants Commission that the students are being discriminated in the Higher Education Institutes on the ground of their community or category.
