**Sub:** M.Phil degree course – Prescription of Norms & Standards for grant of affiliation to offer M.Phil Programme in the affiliated Colleges of Education from 2011–2012 – Reg.

I am, by direction, to inform you that the Syndicate at its meeting held on 10.08.2010 has approved the following Norms and Standards for grant of Affiliation to offer M.Phil programme in the affiliated colleges of the University from 2011-2012, as recommended by the Board of Studies for M.Ed, M.Phil & Ph.D Programme.

**Norms and Standards for Grant of Affiliation to Offer M.Phil**

1. The college which has been accredited by the National Assessment and Accreditation Council (NAAC) with a minimum grade 'B' and which has produced minimum of two batches of M.Ed students shall alone be eligible to offer M.Phil Programme, provided that the qualified teachers are recognized as Guide/Supervisor by the University for guiding M.Phil students are available.
2. Besides fulfilling adequate requirements of infrastructure, instructional space and human and other resources for B.Ed/M.Ed programmes, the college should have one classroom cum seminar hall with in-built ICT facility that can accommodate 12 students. The college should also have 20 educational/research journals with ISSN Number, e-journals, and a minimum of 200 titles of recently published books on educational research and statistics, educational management, Testing and Evaluation, Teacher Education and Educational Technology.

3. In the case of a department recognized for M.Phil research does not have any approved guide for the research work, the recognition/affiliation granted shall cease immediately and the same shall be reported to the University forthwith. If any guide leaves the institution during the course of the study, the assistance for continuation of the research shall be provided by the qualified staff of the institution. However, the substitute for the vacancy (guideship) must be provided by the management within three months.
4. Each recognized guide for supervising M.Phil students should not guide more than 4 students at a time subject to the maximum strength prescribed by the University.
5. An agreement should be entered into with the Teachers already appointed as per the requirements of the University/Tamilnadu Private College (Regulations) Act-1976, as applicable.
6. The additional staff, if any, required as per the norms of work load prescribed by the University consequent on the introduction of M.Phil degree course should be appointed forthwith.
7. All the vacant posts should be filled up with qualified candidates before the commencement of the M.Phil degree course.
8. The maximum number of students that may be admitted to the M.Phil course should not exceed the strength (12) sanctioned by the University.
9. Admission to M.Phil degree course should be made as per the Rules and Regulations prescribed by this University therefor.
10. Excess admission should not be made under any circumstances over and above the sanctioned strength.
11. The college shall strictly adhere to the norms and standards prescribed by the University for M.Phil course.
12. Such other conditions as may be prescribed by the university from time to time should also be followed scrupulously.

The colleges which have fulfilled the above Norms and Standards may apply for affiliation to offer M.Phil degree programme from the academic year 2011 -2012, by obtaining the prescribed form of on payment of Rs.100/- by means of DD in favour of the "Registrar, Tamil Nadu Teachers Education University, Chennai."
